



- 06.14: After 10 hikes since March '22, the Federal Reserve chose to "pause", leaving its target range for interbank overnight lending at 5.00% to 5.25%
- 06.24: Yevgeny Prigozhin, leader of the private military conglomerate Wagner Group, rebelled against military leadership in Russia, only to reverse course the next day

While fixed income returns have yet to register the now higher yields on offer (recall that yields up = price down in bonds), global stocks took off from the October bottom



### **Fixed Income: Broad-Market Returns**





## **Interest Rates: U.S. Treasury Rates**








## **Interest Rates: Spreads**












International small-cap equity (stocks): The MSCI ACWI ex. Developed markets equity (stocks): The MSCI EAFE Investable Market Index (IMI), is an equity index which captures large-, mid- and small-cap representation across Developed Markets countries around the world, excluding the United States and Canada. Emerging markets (EM) equity (stocks): The MSCI Emerging Markets Investable Market (IMI) Index captures large, mid and small cap representation across 24 Emerging Markets countries.
